Facilitator Reports - Science

Secondary Facilitator Mark Winland reviewed the re-tooling of the scope and sequence of secondary science classes, new classes to be added, and efforts for PAWS preparation. Elementary Facilitator Jodi Crago-Beck reported on the implementation of the new curriculum adoption last year.

Alcohol Awareness Proclamation and Report Mrs. Shippy read the proclamation as follows, and Dr. Fall signed the proclamation.

WHEREAS, alcohol is a primary factor in the four leading causes of death for young persons ages 10-24; and

WHEREAS, almost 6,500 persons ages 10-21 die each year; almost 2,400 in drinking and driving crashes, almost 2,400 die from other accidents, falls, fires, etc., 1,500 die in alcohol-related homicides and 300 due to suicide; and WHEREAS, approximately 9.7 million current drinkers in the United States are between the ages of 12-20; and

WHEREAS, adolescents use alcohol more than tobacco or illicit drugs; and WHEREAS, young people begin drinking, on average, at 13.1 years of age; and

WHEREAS, young people who begin drinking before age 15 are four times more likely to develop alcohol dependence than those who begin drinking at age 21; and

WHEREAS, alcohol abuse is linked to as many as two-thirds of all sexual assaults and date rapes of teens and college students; and

WHEREAS, alcohol is a major factor in unprotected sex among youth, increasing their risk of contracting HIV or other transmitted diseases; and WHEREAS, the typical American young person will see 100,000 beer commercials before he or she turns 18 (that is more than for sneakers, gum and jeans); and

WHEREAS, 13 percent of all youth, ages 12-17, had at least one serious problem related to drinking in the past year;

NOW, THEREFORE, I, David R. Fall, Chairman, Campbell County School District Board of Trustees, join the National Council on Alcoholism and Drug Dependence, Inc., (NCADD) and do hereby proclaim that April 2009 is Alcohol Awareness Month in Campbell County School District. As the chairman, I also call upon all citizens, parents, governmental agencies, public and private institutions, businesses, hospitals and schools in Campbell County to support efforts that will increase community awareness, understanding and action to address underage drinking in our community and join us in "Saving Lives: Prevent and Reduce Underage Drinking."

City of Gillette Police Chief Rich Adriaens spoke to the Board about efforts by the Substance Abuse Advisory Council. He noted the goal to have a School Resource Officer in each school and reported that juvenile arrests decreased in 2008 over 2007.

He noted it grew out of professional development training the board received and is an effort to direct efforts of the district for student achievement and success. Mr. Blikre made a motion to approve the policy on first and final reading, Mrs. Durgin seconded and the motion carried. Early Reading Intervention Dr. Ayers and co-chairs of the committee, Barb Parry and Dave Olsen, **Review Committee Report** reviewed the process, results of the committee efforts which investigated successful early reading intervention programs and sites, and conclusions. He thanked Trustee Hepp for her involvement. Dr. Ayers requested the board accept the report and recommended approval of three staffing changes/positions: 1. Restructure the Building Literacy Leader (BLL) position by removing the coaching responsibility. 2. Hire a full-time instructional facilitator in each of the 12 larger elementary schools. 3. Hire an in-district Reading Recovery trainer.
