# SCHOOL IMPROVEMENT GOALS

### ELA:

4J Elementary will improve 4th grade ELA proficiency on the 2022-2023 WY TOPP Assessment from 17% to 50% proficient or advanced by focusing on priority standards, the use of proficiency scales to meet student needs, and Guided Reading groups with more targeted interventions.

#### MATH:

4J Elementary will improve 3rd grade Math proficiency on the 2022-2023 WY TOPP Assessment from 0% to 50% proficient or advanced by focusing on priority standards, continued teacher growth in the implementation of Eureka Math in addition to applying AVMR strategies in Guided Math groups.

#### SCIENCE:

4th grade will embed more scientific texts into the language arts curriculum on a regular basis as well as a focus on reading and creating graphs and diagrams.

#### WELL-BEING:

4J will implement Character Counts.
