- 4. Jump House Mania LLC, not responsible for striking or damaging any underground utility lines/devices (included but not limited to: electrical, plumbing, sprinkler, etc.). It is Lessee's responsibility to tell rental company where inflatable is to be set up and have any underground utility lines marked prior to set up. Jump House Mania LLC, not responsible for discolored/damaged grass due to prolonged inflatable usage.
- 5. Ensure Children are not pushing, colliding, fighting, flipping in bounce house, sliding head first down slides or behaving in a manner likely to cause harm to themselves or others.
- 6. NO pets, toys or sharp objects on inflatables at any time.
- 7. Deposits are non-refundable for party cancellations, unless unable to set up due to hazardous weather conditions in which case a full refund will be issued within 14 days of original party date.
- 8. Jump House Mania LLC, reserves the right to refuse service/play time, to anyone who refuses to follow the rules; regardless of age, size, gender or party being paid in full and will not issue a refund due to a party shut-down in which case the above mentioned rules have been repeatedly broken.
