SCHOOL IMPROVEMENT GOALS

ELA:

Rawhide Elementary will improve 3rd grade ELA proficiency on the 2022-2023 WY TOPP Assessment from 34.9 % to 50% proficient or advanced by focusing on priority standards, the use of proficiency scales to meet student needs, and Guided Reading groups with more targeted interventions. Vertically aligned Professional Learning Communities will build interventions and monitor progress to adjust interventions as needed.

MATH:

Rawhide Elementary will improve 3rd grade Math proficiency on the 2022-2023 WY TOPP Assessment from 45% to 50% proficient or advanced by focusing on priority standards, continued teacher growth in the implementation of Eureka Math in addition to applying AVMR strategies in Guided Math groups.

SCIENCE:

Rawhide Elementary will embed science specific text during our literacy block to incorporate the content throughout the 4th grade curriculum.

WELL-BEING:

Rawhide Elementary will design a Positive Behavior Intervention and Supports model that will promote school pride and incentivize students making good choices.

ACCOUNTABILITY REPORT GOALS

ACHIEVEMENT:

Rawhide Elementary will improve from 51% Meets Target to 55% Meets Target on the Achievement Target as measured by the 2022-2023 WAEA School Performance Report.

GROWTH:

Rawhide Elementary will improve from a 55 MGP (mean student growth percentile) Exceeding Target to a 58 MPG Exceeding Target on the Growth Indicator as measured by 2022-2023 WY TOPP Assessment.

EQUITY:

All consolidated subgroup students in Math and/or Reading will be identified and provided appropriate interventions as needed.
