Absence **CONSENT AGENDA ENDS** Bus Bids MPV Expedition Dr. Ayers explained that the lowest bid was submitted by Sheridan Motors, Suburbans but White's Frontier Motors had requested consideration as a local vendor. Following discussion, Dr. Fall requested a motion to award the bid to Sheridan Motors. There was no motion. Mrs. Hepp then moved to award the bid for four MPV Expedition EL/Suburbans to White's Frontier Motors in the total amount of \$131,360.00 (equal to the bid from Sheridan Motors), Mrs. Durgin seconded, and the motion carried with Mrs. Durgin voting no. Legislative Update Dr. Ayers provided an update regarding issues of district concern including school finance recalibration, education accountability, the potential effects of additional enrollment, and impact on local control. Facilities Update Dr. Ayers updated the board about progress with the School Facilities Commission on School 3. He noted that the re-bid packages were accepted and other issues are being clarified and completed. The contractor, VanEwing, is still on track for completion in 2012. Dr. Ayers suggested it might be time to consider beginning the process to select a name for the school. With no other business before the Board, the meeting was adjourned at 8:40 Adjournment
