Alcohol Awareness Month

Mrs. Shippy read the following proclamation, and Dr. Fall proclaimed April

as Alcohol Awareness Month.

WHEREAS, alcohol is a primary factor in the four leading causes of death for young persons ages 10-24; and

WHEREAS, almost 6,500 persons ages 10-21 die each year; almost 2,400 in drinking and driving crashes, almost 2,400 die from other accidents, falls, fires, etc., 1,500 die in alcohol-related homicides and 300 due to suicide; and

WHEREAS, approximately 9.7 million current drinkers in the United States are between the ages of 12-20; and

WHEREAS, adolescents use alcohol more than tobacco or illicit drugs; and

WHEREAS, young people begin drinking, on average, at 13.1 years of age; and

WHEREAS, young people who begin drinking before age 15 are four times more likely to develop alcohol dependence than those who begin drinking at age 21; and

WHEREAS, alcohol abuse is linked to as many as two-thirds of all sexual assaults and date rapes of teens and college students; and WHEREAS, alcohol is a major factor in unprotected sex among youth, increasing their risk of contracting HIV or other transmitted diseases; and

WHEREAS, the typical American young person will see 100,000 beer commercials before he or she turns 18 (that is more than for sneakers, gum and jeans); and

WHEREAS, 13 percent of all youth, ages 12-17, had at least one serious problem related to drinking in the past year;

THEREFORE, I, David Fall, Chair, Board of Trustees, Campbell County School District, join the National Council on Alcoholism and Drug Dependence, Inc., (NCADD) and do hereby proclaim that April 2011 is Alcohol Awareness Month in Campbell County School District. As the chair, I also call upon all citizens, parents, governmental agencies, public and private institutions, businesses, hospitals and schools in Campbell County to support efforts that will increase community awareness, understanding and action to address underage drinking in our community and join us in "Saving Lives: Prevent and Reduce Underage Drinking."
