Suicide Specialist

Dr. Brown presented information regarding a potential collaboration to hire a community suicide specialist. The board asked that he move forward with determining the feasibility of working with other entities to hire a community suicide specialist.

Legislative Update

Mr. Eisenhauer will be attending an Interim Revenue Committee meeting on August 2 and 3. Dr. Brown and Mrs. Bell provided information on a Recalibration Committee meeting which they attended on July 25. Recalibration consultants will hold meetings for stakeholders to provide information and gain input. Four meetings will be held around the state with the closest one being in Buffalo on August 16. Dr. Brown has sent this information to parents and in the district and encouraged them to attend the meeting. Dr. Brown outlined the process for creating a new funding model and stated that he would be interviewed in Cheyenne regarding the funding model on August 15 and Don Dihle would be interviewed on August 16. The CREG Report is looking positive.

Facility Update

Mr. Eisenhauer provided a facility update. There is some concern regarding the telephone and intercom system at Conestoga Elementary and the remodel at Twin Spruce Junior High being completed before school starts. The addition and remodel at Thunder Basin High School is going well. The Certificate of Occupancy should be issued as soon as a couple of landscaping issues are dealt with. Mr. Eisenhauer will report back on August 15 regarding the status of the Thunder Basin High School stadium. Traffic flow in the Campbell County High School northeast lot has been reorganized and speed bumps added. The new traffic flow will be tried for one year to see if it is beneficial.
